<u>Approval of Board Meeting Minutes</u>: Bruce Daniel moved to accept the minutes, as presented, of the June 17, 2024, Board meeting. George Burnette Dillon seconded the motion, which passed unanimously.

<u>Treasurer's Report</u>: A motion to file the treasurer's report for the month of June, subject to audit, was made by Lee Means. Bruce Daniel seconded the motion, which passed unanimously.

<u>Chief's Report</u>: Chief Bucich has been deployed on the Falls Fire near Burns, OR. The written report was included in the Board packet. Deputy Chief Bart Thompson and Administrative Assistant Dulcy Pierce answered questions.

Grants: Nothing new to report. We are waiting to hear about grant awards.

Hose Testing: Some of the hose tested recently during the annual testing failed. Deputy Chief Bart Thompson is investigating a local company who may be able to mend any repairable hose.

Climate Trailer: Deputy Chief Bart Thompson reported that the State deployed the climate trailer kept at the DRLC to southern Oregon and replaced the trailer with a similar one.

Cedar Flat Arsonist: Deputy Chief Bart Thompson reported that recent events on Cedar Flat Road that involved an arsonist were resolved quickly with the combined response by McKenzie Fire & Rescue personnel and law enforcement.

Personnel: A recent issue arose with a seasonal employee's payroll status. Chief Bucich has reached out to several State agencies and the district's legal counsel. Administrative Assistant Dulcy Pierce provided an overview to the Board. After discussion, the Board felt
